

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to SignatureBrilliance.com, and Fulfilled Life Design, Inc and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Fulfilled Life Design, Inc include SignatureBrilliance.com and Transform Your Brilliance. The Fulfilled Life Design, Inc website is a Online Coaching, Consulting, and Business Development site. By using the Fulfilled Life Design, Inc website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Fulfilled Life Design, Inc may collect personally identifiable information, such as your:

- Comply with the California Electronic Communications Privacy Act;
